In continuation with our previous communications (some letters are attached here, ANNEX-I & ANNEX-II) with you to include more hospitals at CGHS rate and with credit basis, it is further to request you, sir; **kindly extend your personal intervention in this matter** to increase the number of hospitals providing **cashless facilities to the serving BSNL employees of KoITD & other non-territorial circles (like, ITPC, BBNW etc.)**.

Sir, you may be well aware that, the Group Health Insurance policy of BSNL CO (self funded by employees) has not matured yet and the possibility seems to be very less. In this situation, proper health coverage to the employees is a must thing.

BSNL CO also has issued multiple communications on this issue (Supporting letters attached as ANNEX-III & ANNEX-IV). Moreover, recently, **BSNL CO has fixed KPI target for "New Empanelment of Hospitals"** (ANNEX-IV).

Accordingly, the other circles have already taken initiatives to include hospitals & diagnostic centers on credit basis. BSNL CO has also taken initiatives in this regard and empanelled many hospitals & diagnostic centers (ANNEX-V, ANNEX-VI & ANNEX-VII).

Our earnest request to you, kindly intervene to empanel as many as possible hospitals on credit basis in different OAs under KoITD area for better convenience of our employees, please.

For doing this, **proactive action may be taken from CTD admin side and necessary agreements may be carried out with the willing hospitals**. Sir, by empaneling these hospitals, things will be a **win-win situation for both BSNL and CTD employees'** w.r.t. the financial aspect concerned. BSNL has to reimburse the CGHS rate, as usual and employees will also get treatment at CGHS rate from the hospital.

Kindly refer to this office letter of even no. dated 26.04.2023 & 20.06.2023 (available on intranet portal) whereby circles/units of BSNL were requested to pursue with the eminent hospitals in the locality to maximize number of empanelled hospitals under BSNL MRS with the aim to empanel at least one reputed hospital in every OA/BA on Cashless/Credit Facility basis. However, the progress has been slow so far.

To facilitate the process, a list of all the hospitals empanelled on CGHS/ECHS is enclosed for your reference. In OA/BA where CGHS empanelled hospitals are not available, reputed hospitals in OA/BAs can also be empanelled for providing medical services to the employees/beneficiaries and their dependents at special discounted rates (to be arrived by mutual negotiations), subject to the condition that the charges for medical facilities shall be reimbursed by BSNL as per CGHS rates and the excess charges if any, shall be borne by the employee, as per prevailing guidelines in the matter.





Subject: **Considerable amount is being deducted from the Temporary Advance Current Accounts** – requesting to intervene – reg.

Respected Sir,

This is to bring to your kind attention that, from last few months we're observing that, **Union Bank is deducting a considerable amount from the Executives' Temporary Advance Current Accounts.**

Previously, the bank was deducting Rs. 236.00 annually as a General Recovery Charges. This seems normal. But, those executives, **who've opened their Temporary Advance Accounts since the second half of 2022**, are being deducted with huge amount as stated below,

1. General Recovery charges Rs. 236.00 annually, as earlier
2. Min. balance charges Rs. 590.00 quarterly (**i.e. 2360.00 annually**)

Accordingly, if one executive draws a Ty. Adv. of Rs. 2500.00 after one year **will get no amount in hand!**

As per the bank statement, the minimum balance amount in metropolitan area is Rs. 10000.00 (Rupees ten thousand only).

In this situation, our earnest request to you sir, kindly intervene to resolve this matter at your earliest. And if required, kindly take **this matter to BSNL CO for their intervention.** If not intervened timely, through a mass, a large amount of hard earned money will be drained. KTD Accounts wing (or BSNL CO) **may contact the Union Bank to set the minimum balance amount as zero (0).** Alternatively, BSNL CO **may deposit the min. balance amount to the respective accounts as a one time measure.**
