Subject: **Untimely demise of Dibyajit Bhattacharya, JTO/BTS Mtce./West ; conditions of BSNL recruited employees – reg.**

Respected Sir,
We're writing this letter with heavy heart to inform you regarding the untimely demise of one of our young colleague Dibyajit Bhattacharya (38), JTO/BTS Mtce./West yesterday (01.09.2024).

In this grave situation, we're compelled to express some severe service conditions and post-retirement benefits of the **BSNL recruited employees** like late Dibyajit Bhattacharya. The family of this deceased colleague,

- Will receive a meager amount as EPS pension @ **2k – 2.5k** (approx.) per month
- Will not receive any Death relief fund (DRF) as promised by the earlier CMD, as it is not implemented yet
- Family member will not get compassionate ground appointment (CGA), as BSNL has stopped it
- May receive Superannuation Benefit (SAB) annuity @ **1.2k – 1.5K** (approx.) per month

From the above, you can clearly deduce that, **the immediate family of the deceased person will only get a small amount of just Rs. 3.5k – 4k (approx.) per month!!**

One may think over the severe conditions of the family of an executive who passed away untimely! Sir, this is really unfortunate and undesirable. After serving an organization with full devotion, the company **must have some responsibilities toward the ill-fated family.**

Considering the luckless conditions of these BSNL recruited employees, we earnestly and direly, appealing to your good-self **kindly correspond from your high office to the BSNL CO** to consider the following benefits for these set of employees...

1. To re-introduce the CGA with its full extent
2. To increase the quantum of the SAB with its ceiling @30%
3. To introduce the DRF immediately


